## Investment Objective and Policy

The fund aims to provide capital growth by investing in equities of companies worldwide.

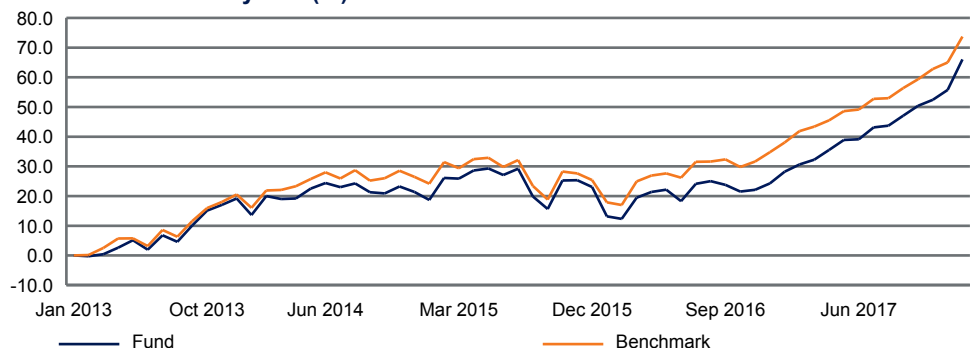
The fund invests at least two-thirds of its assets in equities of companies worldwide. The manager seeks to identify companies that he believes will deliver future earnings growth above the level expected by the market over the long term (we refer to this as 'a positive growth gap'). The fund may use derivatives with the aim of achieving investment gains, reducing risk or managing the fund more efficiently. The fund may also hold cash.

Prior to June 2005 the fund uses the track record of the Schroder World Markets Fund Global Equity as a proxy performance track Record.

# Risk Considerations

- China country risk: Changes in China's political, legal, economic or tax policies could cause losses or higher costs for the fund.
- Counterparty risk: The counterparty to a derivative or other contractual agreement or synthetic financial product could become unable to honour its commitments to the fund, potentially creating a partial or total loss for the fund.
- Currency risk: The fund can be exposed to different currencies. Changes in foreign exchange rates could create losses.
- Derivatives risk: A derivative may not perform as expected, and may create losses greater than the cost of the derivative.
- Equity risk: Equity prices fluctuate daily, based on many factors including general, economic, industry or company news.
- Leverage risk: The fund uses derivatives for leverage, which makes it more sensitive to certain market or interest rate movements and may cause above-average volatility and risk of loss.
- Liquidity risk: In difficult market conditions, the fund may not be able to sell a security for full value or at all. This could affect performance and could cause the fund to defer or suspend redemptions of its shares.
- Operational risk: Failures at service providers could lead to disruptions of fund operations or losses.
- Capital risk / distribution policy: the expenses of this share class are paid out of capital rather than out of investment income. Capital growth will be reduced and in periods of low growth capital erosion may occur.

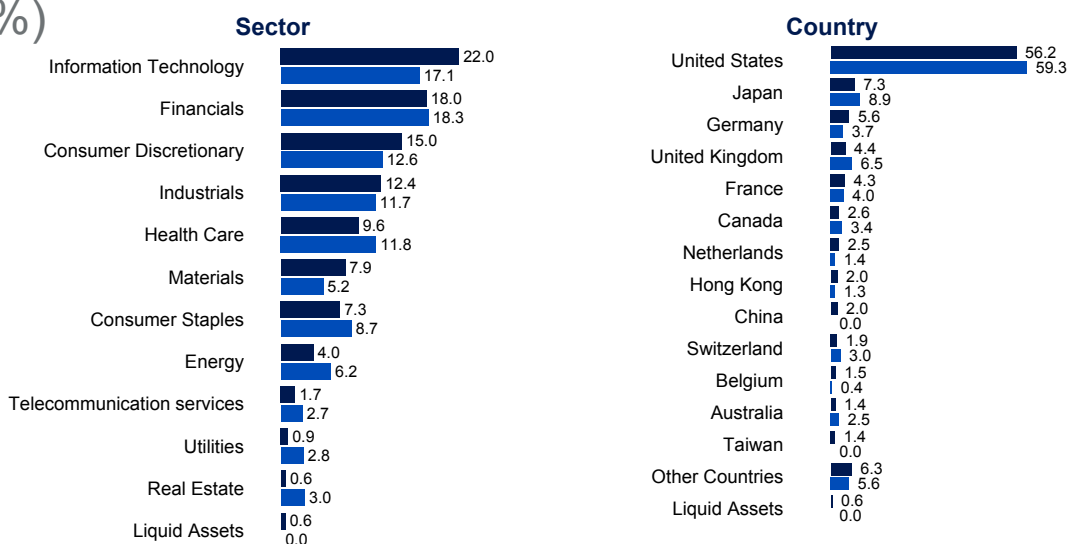
