### Fund objectives and investment policy

The fund aims to provide capital growth.

It may also invest in shares of companies, bonds, foreign currency, money market instruments and hold cash on deposit. The fund will not acquire any physical commodities directly. Derivatives may be used to achieve the investment objective and to reduce risk or manage the fund more efficiently.

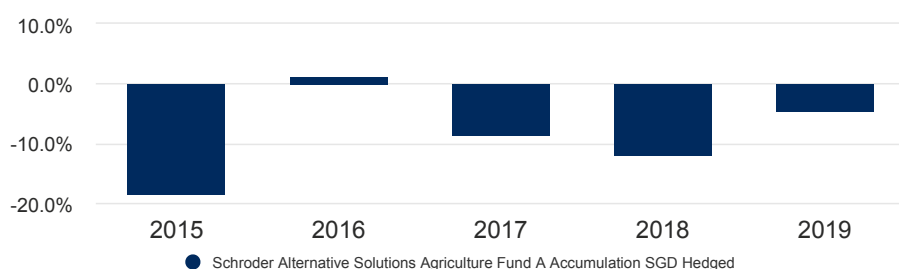

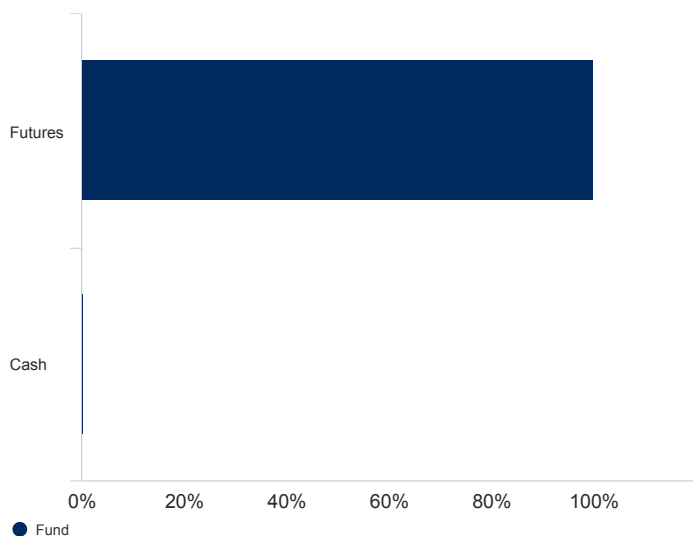

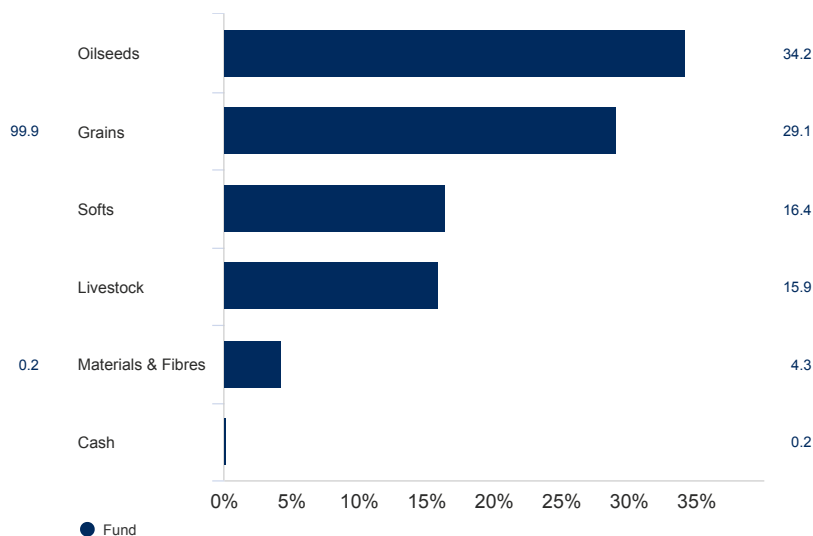
